## Selection and Eligibility Criteria

### Selection Criteria

**To be considered for an Ontario Electrical Safety Award, submissions must:**

- Demonstrate a strong commitment to improving electrical safety; and
- Show measurable impact on advancing safety in Ontario.

### Ontario Electrical Safety Awards Recognition Benefits:



Gain industry and government recognition as a leader in electrical safety in the province.



Receive recognition in the Ontario Electrical Safety Awards media release and promotional materials.



Empower employees and staff to champion a company's safety values and culture.

Demonstrate proven safety leadership to current and prospective customers.

# Selection and Eligibility Criteria

## Eligibility

Individuals or organizations advancing electrical safety in Ontario in one or more of the following categories are eligible for nomination:



**Powerline Safety:** Entrants in this category should highlight initiative(s) focused on the prevention of electrical injuries and fatalities due to powerline contacts.



**Worker Safety:** Entrants in this category should highlight initiative(s) focused on the prevention of serious electrical injuries and electrocutions on the job.



**Consumer and Home Safety:** Entrants in this category should highlight initiative(s) focused on the prevention of electrical injuries and fatalities at home and in the community.

Eligible organizations include businesses, associations or government entities.

## Specific Eligibility Requirements

### A. Eligibility for ESA-Regulated Businesses

Businesses regulated by ESA must be in good standing to receive an award; specifically:

- **Local Distribution Companies (LDCs)** must have an acceptable compliance record noted in its most recent LDC audit report submitted to ESA, as well as no documented non-compliance findings from their most recent annual Due Diligence Inspections.
- **Licensed Electrical Contractors (LECs)** must have no documented licensing infractions or convictions in the previous 24-month period.
- **Master Electricians** must have no documented licensing infractions or convictions in the previous 24-month period.

### B. Eligibility for Individuals and Other Organizations

Nominees do not have to be residents of Ontario, but their efforts must have provided material electrical safety benefits in the province.

### C. Joint Nominations

Collaborative nominations for two or more individuals or organizations working on a common initiative are welcome.

## Selection and Eligibility Criteria

### D. Not Eligible

Individuals in the following categories are **not eligible**:

- ESA employees
- Members of ESA's Board of Directors
- Investigators appointed under Part VIII of the *Electricity Act, 1998*
- Current members of the ESA Ontario Electrical Safety Awards Advisory Committee

### E. Alignment with ESA Values

Nominations may be reviewed for alignment with ESA's corporate values: safety, accountable, people focused, inclusive, courage and integrity and adaptive.

## Selection Criteria

- Demonstrate a strong commitment to improving electrical safety.
- Have an impact on the state of safety in Ontario.

Together, we can protect Ontarians from electrical harm.

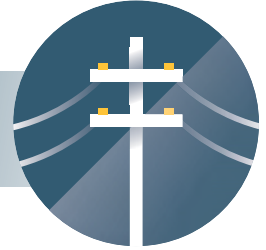

## Powerline Safety



### 2025 Winner:

#### Chris Connelly of Aecon Utilities

Recognized for his transformative impact on safety practices at Aecon Utilities, Chris Connelly led the development of a comprehensive, competency-based training and qualification program for powerline technicians. Additionally, Chris overhauled Job Hazard Assessments to ensure they reflected real field conditions and evolving client standards. Chris's efforts resulted in a measurable increase in worker confidence and field preparedness. Notably, there was a 40% reduction in near-miss safety incidents and zero recordable injuries tied to tasks covered by revised assessments.

### 2024

#### Bluewater Power, Hydro One & London Hydro

Recognized for successfully transporting enormous beer tanks, each over 33 metres long and 6.62 metres wide, from Sarnia Harbour to the Labatt Brewery in London, Ontario. This largescale project employed best practices in safely hoisting, cutting and reconnecting powerlines, minimizing power disruptions along the route and keeping the public in affected areas well-informed through letters and auto-dialer messages.

### 2023

#### Roxborough Bus Lines

Recognized for taking a significant step towards ensuring the safety of schoolchildren and its drivers by having specialized training on the dangers of downed powerlines after a near miss incident with a downed powerline. The company trained over 500 drivers to understand the risks associated with downed powerlines and how to protect both the students on board and themselves in such scenarios.

### Worker Safety



#### 2025 Winner:

#### Oneida Energy Storage

Honoured for its exceptional worksite safety performance in delivering Canada's largest operational energy storage facility. Five project partners — Northland Power, Six Nations of the Grand River Development Corporation, Aecon, NRStor and Mississaugas of the Credit Business Corporation — collaborated to build a safety culture that put workers first, supported by a joint monitoring framework, extensive workforce training and over 550 safety inspections. At the height of construction, hundreds of people were working on the project, logging nearly 300,000 hours without a single lost-time injury.

#### 2024

#### PUC Services Inc.

Recognized for its commitment to educating distracted drivers about the importance of staying cautious near road work zones to ensure the safety of road workers. Through their Road Safety Video campaign, PUC Services Inc. featured testimonials from actual road workers, highlighting real-life dangers and the need for driver attentiveness. The campaign also featured messages from the City of Sault Ste. Marie, the local Construction Association, Fire Service, Paramedic Service and Police Service.

#### 2023

#### Utilities Kingston

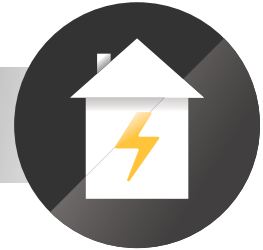
Recognized for their strong commitment to educating workers on electrical safety for both their own employees and contractors working in the Eastern region with their annual two-day Safety Days. The Safety Days provided safety requirements and information to employees of Utilities Kingston and contractors working for the City of Kingston on underground and overhead utility infrastructure. The annual event featured a diverse range of training sessions and informative presentations from guest speakers. The event served as a platform for disseminating crucial safety knowledge and best practices, fostering a culture of safety excellence within the organization and the broader community.

#### 2025 Winner:

#### London Hydro

Spotlighted for building lifelong safety habits for young Ontarians through their School Electricity Safety program. Running for over 30 years, the program delivers interactive, age-appropriate learning for students in grades 3 to 8 across the London region. In 2025, the program reached over 6,235 students across 33 schools. By constantly evolving the subject matter to reflect the safety needs of today's youth, the program serves as a model for long-term investment in community education.

#### 2024

#### Ellexicon Energy

Recognized for its contributions to the Children's Safety Village in Belleville and the Kids Safety Village of Durham Region. Understanding that children learn best through discussion and play, Ellexicon Energy empowered children to explore electrical equipment in a safe environment, learn about powerline and home electrical safety and gain the knowledge needed to avoid unsafe situations in the real world.

#### 2023

#### Innovation Electric Inc.

Honoured for their contributions to educating children and their dedication to bridging language barriers and ensuring electrical safety information is accessible to all. Innovation Electric Inc. launched a colouring contest for children to participate in with their families in their own language. Through this initiative, Innovation Electric Inc. not only empowered children but also their families and communities to make informed decisions regarding electrical safety.
