- 1. On September 28, 2023, the Electrical Safety Authority ("ESA") imposed two administrative penalties orders ("APOs") against the Appellant, pursuant to subsection 113.18.1 of the *Electricity Act, 1998*, in respect of two contraventions ("Contravention 1" and "Contravention 2") as detailed in the APOs.
- 2. On October 13, 2023, the Appellant appealed the APOs.
- 3. On November 21, 2023, a pre-hearing case conferences was held. I served as Case Conference Chair. As a result of discussions at the case conferences, this matter has now settled.
- 4. The parties have proposed a settlement, which is attached hereto as Appendix "A" to this Order ("Settlement"). The parties have requested certain orders to be made on consent as part of the Settlement, which I am prepared to make.
- 5. By way of their request for this relief, both parties accept that I have jurisdiction to make the order sought pursuant to 0. Reg 187/09 (including subsection 18(4)) and the ESA's Rules of Procedure, and I accept that I do have that authority.
- 6. Accordingly, on consent of the parties and at their request, I order that:
 - a. The APO with respect to Contravention 2 is rescinded.
 - b. The APO with respect to Contravention 1 is amended as follows: the administrative penalty amount is reduced to \$900.00, to be paid in \$75/month instalments for twelve (12) consecutive months, commencing on January 1, 2024 (or with consent of the parties commencing February 1, 2024).
 - c. The "Terms of Settlement" (attached as Schedule "A" to the Settlement, which is attached as Appendix "A" to this Order) are hereby incorporated as part of this Order.
- 8. Given that the matter has been resolved, this appeal proceeding is hereby dismissed, on a without costs basis.
