| <p>Additional Information (if necessary)</p> | <p>Mr. Hashemi, through paralegal Richard Cohen, pled guilty to the above noted offences. By way of joint position, he received a fine of \$1500 with respect to count 1, a fine of \$3000 with respect to count 4 and a suspended sentence with probation for 2 years with an added condition that he not contravene the Electricity Act, including the performance, promotion, employment or any other prohibited action under the Electricity Act without a license in relation to counts 2, 3 and 5. The remaining counts were withdrawn. Mr. Hashemi was given 1 year to pay.</p> |
